#### INTENDED USE

WARECLEAN EC PENTA provides superior cleaning and pre-disinfection of medical-surgical instruments, medical devices, thermosensitive instruments, and endoscopes. It contains in powerful combination of enzymes (amylase, cellulase, lipase, mannanase and protease) that accelerate soil breakdown. It can be used in manual, ultrasonic, and automatic washing machines and washing tunnels with its low foam formula.

#### **COMPOSITION**

Enzymatic complex (amylase, lipase, protease, cellulase, mannanase), glycerol, isopropanol, ethanol (96%), EDTA tetrasodium salt, urea, trisodium phosphate, sodium hydroxide, propylene glycol, butyl glycol, corrosion inhibitor, surfactants, triethanolamine, and RO water.

### **CONTRAINDICATIONS**

It should not be used in devices that use phosphate-free and neutral detergents.

#### **PRECAUTIONS**

- Protective gloves (butyl rubber, nitrile rubber, polyethylene, or double-gloved latex), eye
  protection, face masks, and liquid-proof gowns should be worn when cleaning and
  sterilizing/disinfecting soiled devices and equipment.
- The outer surface of contaminated, reusable medical devices should be wiped with a cloth.
- The user MUST adhere to the Instruction for Use since any modification will affect the effectiveness of the cleaner.

## HOW TO USE

#### 1- Pre-cleaning:

Wipe down the external surface of the surgical instrument with gauze or a cloth, to remove the mucous membrane, blood, and filth that adhere to the external surface. Either moistened gauze or dry gauze is fine.



**2- Cleaning:** Dilute with hot or cold tap water. Depending on the protein residue degree, the dilution rate is between 0,25% and 1%. For very dirty instruments 4 pumps (20mlx4) for 8 Liters of water. For relatively clean instruments 1 pump (20mlx1) for 8 Liters of water. Immerse the instruments into the container. Wait for 5-15 minutes. Scrub the instruments gently with a soft brush. Rinse thoroughly with distilled water (sterile distilled water is preferred). Wipe thoroughly and dry with an absorbent cleaning path. Sterilize the instruments or immerse them to a new soaking bath full of high-level disinfectant. It is used for ultrasonic bath; at 45°C, 1 minute at 0.5%. New ready-to-use solutions must be prepared every day.

# WARNINGS AND POTENTIAL ADVERSE EFFECTS

Causes severe skin burns and eye damage. Do not breathe dust/fumes/gas/mist/vapors/spray. Wear protective gloves/ protective clothing/eye protection/face protection. IF SWALLOWED: Rinse mouth. Do NOT induce vomiting. IF INHALED: Remove the person to fresh air and keep comfortable for breathing. IF IN EYES: Rinse cautiously with water for several minutes. Remove contact lenses if present and easy to continue rinsing.

Long-term skin contact may cause minor irritation with itching. There is no evidence of adverse reproductive or carcinogenic health.

## STABILITY AND STORAGE


Store in its original packaging, without direct sunlight, in a shady environment. Keep it tightly closed and in a well-ventilated environment.
