INTENDED USE: OPA Neutralizer is used for neutralization of the disinfectant containing orthophthalaldehyde. Ortho-phthalaldehyde can be dangerous for aquatic life (H400: Very toxic to aquatic life. H410: Very toxic to aquatic life with long-lasting effects). ROSA-CHEM OPA is a chemical agent to neutralizes ortho-phthalaldehyde side effects and makes it safe for the environment, especially aquatic life. After neutralization, it can be discharged to the sewage system as household waste. If not neutralized, it must be discharged as chemical waste.

HOW TO USE

Stir 10 minutes. After 10 minutes you can discharge safely the neutralized solution according to the waste disposal rules of your country. Neutralized solution is not harmful to the environment.

WARNINGS AND POTENTIAL ADVERSE EFFECTS

IF SWALLOWED: Rinse mouth. IF IN EYES: Rinse cautiously with water for several minutes. Remove contact lenses if present and easy to continue rinsing.

STABILITY AND STORAGE


